### **COMPAD Project Sensitisation Workshop**

As part of the project Advocating for 'Functional Competition Regime in Ghana (COMPAD)', CUTS Accra, Ghana held a sensitisation workshop geared towards Small and Medium Enterprises (SMEs) and Policy on March 03, 2016 at Coconut Grove Hotel, Accra (Ghana) as part of the advocacy activities for the COMPAD project. The event was attended by stakeholders from the various Ministries, private sector, business associations, the academia and the media.

### **CUTS-ZABS Meeting under CREW Project**

On April 29, 2016 CUTS International, Lusaka, Zambia hosted a technical committee meeting in collaboration with the Zambia Bureau of Standards (ZABS) on 'Passenger Vehicle Body Construction Draft Standard'. The meeting was organised under a CUTS project entitled 'Competition Reforms for Enhancing Social and Economic Welfare in Developing Countries' (CREW). One of the outcomes of the CREW project was the need to improve the quality control system for public buses to ensure that only buses of good quality are allowed on the roads.

#### **ONGOING PROJECTS**

### Competition Reforms in Key Markets for Enhancing Social & Economic Welfare

CUTS Lusaka (Zambia) and CUTS Accra (Ghana) with the aid of Department for International Development (DFID) and BMZ (Germany) has implemented Competition Reforms in Key Markets for Enhancing, Social & Economic Welfare in Developing Countries (CREW) project implemented to better demonstrate the measurable benefits of an effective competition reforms process in developing countries and ensure long-term support for competition reforms.

### Literature Review and Feasibility Study on Approaches to Assess Poverty Impacts

CUTS Nairobi, Kenya has undertaken Literature Review and Feasibility study on approaches to assess poverty impacts of the East Africa Community (EAC) economic integration supported by DFID through European Centre for Development Policy Management (ECDPM). The project aims at providing a summary of the existing evidence in the literature on the poverty impact of regional integration in different regions around the world.

### Advocating for a Functional Competition Regime — COMPAD Project

CUTS Accra, Ghana with support from the Business Advocacy Challenge (BUSAC) Fund, is implementing a 15-month project entitled: 'Advocating for a Functional Competition Regime in Ghana' referred to as the COMPAD Project. The goal of the project is to facilitate the process towards evolution of a national competition regime in Ghana, through an informed process, incorporating views of key actors and with support from Ghanaian businesses and consumers.

### **Engaging with Economic Think through ZEAP**

The objective of the Luska Centre's, Zambia Economic Advocacy Programme (ZEAP) initiative under DFID is to engage with selected civil society organisations that are economic think tanks in Zambia. The main interests of the initiative is to build the capacity of these economic think tanks in areas of advocacy, research and M&E through providing core funding to these organisations.

### IVORI-III: Strengthening CSOs and NSAs

CUTS Nairobi, Kenya has implemented the project 'Integrating the Voice of CSOs in Regional Integration Process — Eastern and Southern Africa (IVORI-III)' project supported by Oxfam Novib to strengthen the ability of civil society organisations (CSOs) and Non-State Actors (NSAs) to meaningfully participate and influence the Tripartite Free Trade Agreement (TFTA) implementation process for better results on the ground.

### **CUTS Consumer Survey**

CUTS Lusaka, Zambia with the support from the Zambia Economic Advocacy Programme has undertaken a consumer survey to assess how the current economic situation of the country is having an impact on consumer welfare in different sectors of the economy. A tool has been developed based on specific variables and this tool will be the basis of the subsequent similar surveys that will enable CUTS to publish quarterly and biannual surveys documenting consumer issues and concerns.

### Diagnostic Study for Awareness among Consumer Groups

CUTS Nairobi, Kenya with the aid of HIVOS has implemented the project entitiled 'Diagnostic Study to Build the Capacity/Awareness among Consumer Groups to 'Demand for Renewable Energy (RE) & Energy Efficiency (EE) in Kenya (DREEK)' to increase long-term capacity/awareness of consumer groups to demand for RE and EE initiatives, and also to understand, document and communicate their specific needs to relevant policy makers.


### Competition Issues in the Re-introduction of TV Licence Fees

The decision granted to the state broadcaster, the Ghana Broadcasting Corporation (GBC) to resume the collection of TV licence fees from the public, will lead to market distortions and anticompetitive practices. With the recent court ruling, the GBC is nationwide collection of the TV licence fees has been effective since August 11, 2015. The re-introduction of the TV licence fees generated a lot of anger among Ghanaians, but more importantly, it raised the critical issue of ineffective competition in the TV broadcasting industry.

### From EAC to TFTA Integrating the Voice of the Civil Society in Kenya


This research publication presents the state of involvement of Kenyan Non-State Actors, particularly CSOs, in the East African Community (EAC) and the ongoing TFTA initiative. This documentation can serve as a baseline for upcoming interventions and studies. The main finding of the Kenyan study is that the EAC has a working engagement framework in place with certain gaps both in design and implementation, which can be improved upon for non-state actors' engagement under the TFTA.
